Wildfire Batting Cage & Facility Rules & Regulations

- 1. Use of the Batting Cage is on a first come, first serve basis. Booking online will take precedence over walk ins. The use of batting cage by teams or individuals must be scheduled by Wildfire, prior to use.
- 2. All participants must have a Waiver on file with Wildfire. Participants under age 18 must also have form signed by legal parent or guardian.
- 3. Wildfire is not responsible for any injuries incurred while using this facility.
- 4. Youth under the age of 13 must be accompanied by an adult.
- 5. Only 1 person is permitted in the cage when using the pitching machine. Only 2 people are permitted inside the cage at one time: the Batter and Pitcher when not using the machine.
- 6. No Food or Drink permitted in the batting cage or on the synthetic turf. Sunflower seeds are prohibited in the facility.
- 7. All batters must wear helmets at all times while in cages. Adult coaches within the cages must remain behind protective 'L' screens during live pitching. Catchers in the cage will wear full protective gear.
- 8. Participants must wear closed-toe shoes (no cleats).
- 9. No practice swings or swinging of bats allowed outside the cages at any time. This includes hitting 'soft toss' outside the nets.
- 10. Spectators or individuals "on-deck" must remain 3' back from suspended netting at all times, behind warning lines.
- 11. No hitting balls against facility walls.
- 12. No playing catch anywhere outside cage, whether inside the building or outside without permission.

- 13. Protective netting shall never be pulled back in any way.
- 14. Absolutely no unauthorized persons shall enter the cage area.
- 15. Immediately notify the Wildfire manager on duty regarding any equipment, safety hazards, or unsafe conditions that may exist.
- 16. When batting cage is in use, the access door must be closed to prevent outside observers from being exposed to hit or thrown balls.
- 17. Coaches with athletes using the cage must supervise other athletes under their direction that are elsewhere in the facility.
- 18. Only the balls that were specifically purchased for the pitching machine may be used in the pitching machine.
- 19. All equipment must be returned to its proper place when you have finished using the batting cage.
- 20. Wildfire is not responsible for lost or misplaced personal property. Please keep track of your equipment and belongings.
- 21. Any person entering the facility is expected to use common sense and maintain a proper lookout for their own safety.
- 22. Machines are not to be opened or fixed under any circumstances by anyone other than Wildfire Staff or authorized persons unless specifically allowed by Wildfire. Anyone touching any machines without prior specific authorization from Wildfire shall be liable for any resulting damage to the machine, facility, or persons.

ANY VIOLATION OF THESE RULES WILL RESULT IN THE PARTICIPANT'S IMMEDIATE EJECTION FROM THE FACILITY AND MAY ALSO RESULT IN THE LONG-TERM LOSS OF FACILITITES PRIVILEGES.
